
**TRADE CIRCULAR**

**Sub:** Commencement of operation at the Berth No.-07 & Back Up Area of  
NSD under Syama Prasad Mookerjee Port, Kolkata

Principal Commissioner of Customs (Port) vide communication issued on 07.05.2026 has pleased to grant permission to M/s. JSW Kolkata Container Terminal Pvt. Ltd. (M/s. JSW KCTPL) to commence operations at Berth No. 7 & its Back Up Area of NSD under Syama Prasad Mookerjee Port, Kolkata, under the provision of Regulation 8 of Handling of Cargo in Customs Area Regulation, 2009 as amended read with Public Notice No. 28/2026 (Port) dated 10.04.2026.

The newly appointed custodian M/s. JSW KCTPL will continue its operation at Berth No.-07 & Back Up Area as long as the requirements of the Customs Act, 1962 along with relevant Rules, Regulations, Notifications, Public Notices and Circulars etc. made there under are fulfilled by the Custodian & Customs Cargo Service Provider. The custodian, M/s. JSW KCTPL, shall follow the procedures for movement and handling of containerized EXIM Cargo only at Berth No.-07 & Back Up Area including the common user facilities as extended by SMPK mandated by above statutes and also enshrined under various Public Notices and Circulars issued time to time in this regard.
